**ORDER:**

In the reference 2<sup>nd</sup> cited, the Commissioner of Technical Education, A.P. has stated that the Government have issued orders in G.O.Ms. No.209, Higher Education (TE.1) Dept., dt:20-11-2010 for implementation of A.P. Revised AICTE Scales of Pay, 2006 to the Teachers, Librarians and Physical Education personnel working in Govt. Polytechnics in the State w.e.f. 01-01-2006. In the G.O it was ordered, among others, that the said A.P. Revised AICTE Scales of Pay, 2006 are applicable to those Govt. Polytechnic Teachers / Librarians / Physical Directors who have been already retired from Govt. Service either Voluntarily or on attaining the age of Superannuation or died while in Service on or after 01.01.2006 and are drawing AICTE Scales of Pay, 1996. Further, the State Rules shall apply in respect of Pension / Gratuity and other retirement related benefits for those drawing AICTE Scales on par with State Govt. Employees from time to time, but the G.O. remained silent regarding the consolidation of Pension to those Teachers who retired between 01.01.1996 and 31.12.2005 in the A.P. Revised AICTE Scales of Pay, 1996.

2. He has stated that Government issued orders in G.O.Ms.No.54, Higher Education(UE.II) Dept. Dt:08-06-2011 consolidating the pension of the pre-2006 pensioners and family pensioners of University / Government and Aid- Colleges teachers retired between 01-01-1996 and 31.12.2005 w.e.f 01.01.2006. Based on the said orders of the Government, the President of A.P. Polytechnic AICTE Retired Teachers Association requested for consolidation of pension who retired between 01.01.1996 and 31.12.2005 and drawing AICTE 1996 Scales, and the staff retired or died on or after 01-01- 2006. The request of the said Association was examined by the Government, and issued ordered in G.O.Ms.No.71, Higher Education (TE-1) Dept. Dt: 18-09-2012 sanctioning the consolidated pension in the AICTE Scales of Pay 2006 to the Teachers, Librarians and Physical Directors of Govt. Polytechnics who retired between 01-01-1996 and 31-12- 2005 and who are drawing AICTE Scales of Pay, 1996 w.e.f. 01.01.2006 on similar basis as per the orders issued in G.O.Ms.No.54, Higher Education (UE.II) Dept. Dt.08-06-2011 and also enhancing the ceiling of Gratuity as per G.O.Ms.No.53, HE(UE-II ) Dept. Dt: 08-06-2011.

3. The Commissioner of Technical Education, A.P. has further stated that the AICTE Scales of Pay 1986 were initially extended to the Teachers working Govt. Polytechnics notionally w.e.f. 01.01.1986 with the monetary benefit from 01.04.1997 by re-designating the then existing posts of Lecturers and Workshop Superintendents as Senior Lecturers and Associate Lecturers as Lecturers vide G.O.Ms.No.4, Education (TE-2) Dept., Dt:01-01-1998 read with G.O.Ms.No.580, Higher Education (TE-2) Dept., Dt:03-12-1998. Later, the revised AICTE Scales of Pay 1996 were also extended to the Teachers, Librarians and Physical Directors notionally with effect from 01-01-1996 and monetary benefit from 01.4.1999 in G.O.Ms.No.72, Higher Education (TE-2) Dept., Dt:26.09.2002. He has stated that there are 54 staff members who retired from Govt. service on superannuation prior to 01-01-1996 in different cadres in Technical Education Dept., and drawing pension in A.P. State Scale of Pay and they now requested for extension of AICTE Scales of Pay revised from time to time and consolidation of pension in the AP Revised AICTE Scales of Pay, 1996 as on

01.01.1996 and in A.P. Revised AICTE Scales of Pay, 2006 with effect from 01.01.2006 as was sanctioned to the University / Govt. and Aided College, Teachers retired in U.G.C Scales of Pay on or before 31-12-1995 vide G.O.Ms.No.31, Higher Education (UE.II) Dept., Dt:24-05-2013. The Commissioner of Technical Education, A.P., vide his letter in the reference 4<sup>th</sup> read above has stated that the total financial implication involved in the proposal is worked out to Rs.1,27,03,712/- (Rupees One crore twenty seven lakhs three thousand seven hundred and twelve only).

4. The Special Commissioner of Technical Education, A.P., has requested the Government for issue of necessary orders sanctioning consolidated pension in the A.P. Revised AICTE Scales of Pay, 1996 w.e.f. 01.01.1996 and thereafter in the AP Revised AICTE Scales of Pay, 2006 w.e.f. 01.01.2006 to the Teachers, Librarians and Physical Directors of Technical Education Dept. who retired prior to 01.01.1996 on the similar lines of the orders issued in G.O.Ms.No.31, Higher Education (UE.II) Dept. Dt: 24-05-2013.

5. Government after careful examination of the proposal of the Commissioner of Technical Education, A.P., Hyderabad, Government hereby sanction consolidated pension in the A.P. Revised AICTE Scales of Pay, 1996 w.e.f. 01.01.1996 and thereafter in the AP Revised AICTE Scales of Pay 2006 w.e.f. 01.01.2006 to the Teachers, Librarians and Physical Directors of Government Polytechnics who retired in between 01.01.1986 and 31.12.1995, on the similar basis of the orders issued in G.O.Ms.No.31, Higher Education (UE.II) Department, Dated 24.05.2013.

6. This order issued with the concurrence of Finance (HR.V) Department vide their U.O. No.34021/18/2017-HR.V, Dt.13.06.2017
