## **OFFICE ORDER**

## Precautionary Measures to contain the spread of Covid 19

It has been reported that Ms. Geetha Raghu, DAG (Admn & Funds) and Shri S. S. Sarfare, Sr. DAG (Accounts & Pension) have been tested COVID 19 Positive on 27/06/2020 and 29/06/2020 respectively. Ms. Geetha Raghu, DAG (Admn & Funds) had last attended office on 19/06/2020 and Shri S. S. Sarfare, Sr. DAG (Accounts & Pension) had last attended office on 22/06/2020.

In view of the above following instructions are hereby issued:-

- 1. Ms. Geetha Raghu, DAG (Admn & Funds) and Shri S. S. Sarfare, Sr. DAG (Accounts & Pension) and Officers/Officials who came in their contact (direct list as per Annexure-I) are instructed to remain in self home quarantine for 14 days w.e.f 22/06/2020
- 2. The officers/Officials as per list Annexure -I shall undergo self home quarantine compulsorily as per Ministry of Health directive available at https://www.mohfw.gov.in/pdf/guidelines for home quarantine.pdf and guidelines dated 04/06/2020 and closely monitor their health for 14 days w.e.f 22/06/2020 . These officials shall undergo testing as per ICMR protocol. In case there are officers or officials who are aware of their direct contact with Ms. Geetha Raghu, DAG (Admn & Funds) and Shri S. S. Sarfare, Sr. DAG (Accounts & Pension)- but not mentioned in Annexure-I, are required to report immediately to Office, for further action in the matter.
- 3. The other Officers/officials as per Annexure-II, who were in indirect contact with Ms. Geetha Raghu, DAG (Admn & Funds) and Shri S. S. Sarfare, Sr. DAG (Accounts & Pension) or the officers / officials who are aware of their indirect contact but not mentioned in Annexure-II, shall monitor their health closely. In case they develop any of the symptoms of COVID 19, as notified by M/o Health, they shall also go for COVID 19 testing and intimate the advice tendered by Doctor and report development from time to time.
