*Subject : Grant of dearness relief to the Karnataka Government pensioners/family pensioners with effect from 01-07-2019.*

In continuation to this office circular No. Pen. Co-ordn./Karnataka/Vol.-VI/DR/38 dated 11-06-2019, this is to state that the Government of Karnataka in their Order No. FD 15 SRP 2019 dated 19-10-2019 has sanctioned dearness relief on revised basic pension/family pension to their pensioners/family pensioners including the pensioners/family pensioners of the aided educational institutions whose pension/family pension is paid out of the Consolidated Fund of the state of Karnataka at the rate and from the date as under :

<i>Date of effect</i>	<i>Rate of dearness allowance per month</i>
01-07-2019	11.25% of basic pension/family pension

2. Payment of dearness relief involving fraction of 50 paise and above shall be rounded off to the next rupee and fraction less than 50 paise shall be ignored.

3. This order shall also be applicable to the retired teachers who were on 2006 revised UGC/AICTE/ICAR Scales of pay and who retired prior to 01-01-2016.

4. This order shall not be applicable to pensioners who were drawing pay in the UGC/AICTE/ICAR/NJPC Scales, who were on 2006 revised scales of pay and who retired on or after 01-01-2016. Separate orders will be issued in respect of those pensioners.

5. Having been authorised by the Principal Accountant General (A&E), Karnataka in their letter No. PM/G III/B 271/2019-20/SS 14430/144 dated 31-10-2019, it is requested to make necessary arrangement for payment of dearness relief to the category of Karnataka Government pensioners mentioned at para 1 & 3 above @ 11.25% with effect from 01-07-2019 after proper adjustment of the amount already paid.

6. The charges on this account are debitable to the head "8793-I.S.S.A/es.; Government of Karnataka etc."
