Sanctioning Authority in revised Annexure-II/III, as laid down in Govt. of West Bengal, Finance

Department, Pension Branch Memo. No. 55-F (Pen) dated 21/1/2020, in absence of specific

authority from this Office in individual cases.

In this connection, it is reiterated that all Pension Disbursing Authorities will start

disbursement of revised pension/family pension of the aforesaid pensioners/family pensioners

provisionally w.e.f. 1/1/2020 on the basis of a copy of Annexure II/III, forwarded by the concerned

Pension Sanctioning Authority directly at the disbursement end which has to be adjusted later with

the final authority issued by this Office in this respect. It is to be kept in mind in this regard that no

payment of balance amount of revised gratuity and commuted value of pension on additionally

commuted portion of pension will be made provisionally until revised authority for this purpose is

issued by this office.

All concerned Pension Disbursing Authorities within this State are, therefore, requested to

make necessary arrangement for payment of revised pension/family pension provisionally as stated

above without waiting for receipt of authority from this Office in each individual case as mentioned

in the Memorandum ibid to mitigate the hardship of the old aged pensioners of this State.
