Subject : Grant of Dearness Relief to the Haryana Government pensioners/family pensioners with effect from 01-07-2019.

In continuation to this office circular Pen. Co-ordn./Haryana/Vol.- VII/DR/66 dated 24-07-2019, this is to state that the Government of Haryana in their OM No. 4/1/2019-2FR/32148 dated 25-11-2019 has sanctioned dearness relief on revised pension/family pension of their pensioners/family pensioners as under :

Date of effect	Rate of dearness relief per month
01-07-2019	17% of basic pension/family pension

2. All other conditions for payment of dearness relief to pensioners/family pensioners on revised pension/family pension contained in FD's instructions No. 2/23/2016-1 Pension dated 03-03-2017, as circulated under No. Pen. Co-ordn./Haryana/Vol.- VII/Revision/57 dated 04-07-2017, shall be applicable.

3. Having been authorised by the Principal Accountant General (A&E), Haryana in their letter Nos. Pen-1/Gen-26/Grant of Dearness Relief/2019-20/3333 – 3424 dated 24-12-2019 and Pen-1/4/Gen-26/19-20/4234 dated 03-03-2020, it is requested to make necessary arrangement for payment of dearness relief to all eligible Haryana Government pensioners/family pensioners @ 17% on their basic pension/family pension with effect from 01-07-2019 after proper adjustment.

4. The charges on this accounts are debitable to the head "8793-I.S.S.A/cs.; Government of Haryana etc."
