Subject: Grant of Temporary Increase (dearness relief) to the Gujarat Government pensioners/family pensioners on their pre-revised pension/family pension with effect from 01-07-2019.

In continuation to this office circular No. Pcn.Co-ordn./Gujarat/Vol.-V/DR-Pre-rev/115 dated 20-01-2021, this is to state that the Government of Gujarat in their F D Resolution Nos. HGV-102017-O-1201-P dated 20-03-2020 has sanctioned Temporary Increase (dearness relief) on pension/family pension of their pensioners/family pensioners drawing pension/family pension as per 6th Pay Commission (this office circular No. Pen.Co-ordn./Gujarat/Vol.-V/Revision/72 dated 25-08-2009), as under:

Date of effect	Rate of Temporary Increase per month
01-07-2019	164% of basic pension/family pension

- 2. The amount of Temporary Increase mentioned above will be paid from 01-01-2020 in cash. The instructions regarding the payment of arrears of Temporary Increase on pension/family pension for the period from 01-07-2019 to 31-12-2019 will be issued as and when the authority in this regard will be received from the o/o the Principal Accountant General (A&E), Gujarat.
- 3. Temporary Increase at the rates indicated in above table will also be admissible on the additional basic pension/family pension available to older pensioners/family pensioners based on their age.
- 4. Payment of Temporary Increase involving a fraction of a rupee shall be rounded off to the next higher rupee.
- 5. Other provisions governing grant of Temporary Increase to pensioners such as regulations of dearness relief during employment/re-employment, regulation of Temporary Increase, where more than one pension is drawn etc. will remain unchanged.
- 6. Having been authorised by the Principal Accountant General (A&E), Gujarat in their letter No. Pension/G.R./Special Scal/GOG-06/2020-21/OW No. 774 dated 11-01-2021, it is requested to make necessary arrangement for payment of Temporary Increase to all eligible Gujarat Government pensioners/family pensioners on their pre-revised basic pension/family pension @ 164% with effect from 01-01-2020 after proper adjustment.
- 7. The charges on this account are debitable to the head "8793-I.S.S. A/cs.; Government of Gujarat etc."
