In continuation to this office circular No. Pen. Co-ordn./Haryana/Vol.- VII/DR-unrev&Ex-MLA/87 dated 23-08-2016, this is to state that the Government of Haryana in their circular letter No. 4/1/2017-1FR/12091 dated 28-08-2020 has sanctioned dearness relief to their pensioners/family pensioners on their un-revised pension/family pension (drawing pension/family pension as per Fifth Pay Commission) as under:

01-01-2019	295% of basic pension/family pension	
01-07-2019	312% of basic pension/family pension	

- 2. All other conditions relating to payment of dearness relief to the pensioners/family pensioners on un-revised pension/family pension contained in the O. M. No. 2/51/08-1Pension dated 17-04-2009 (circulated vide No. Pen. Co-ordn./Haryana/Vol.- VI/Revision/85 dated 14-09-2009) will remain same.
- 3. Payment of dearness relief involving a fraction of rupee shall be rounded off to the next higher rupee if the same is 50 paise or above. Conversely, it will be rounded off to the lower side if the same is less than 50 paise.
- 4. Having been authorised by the Principal Accountant General (A&E), Haryana in their letter No. Pen-1/Gen-26/Grant of Dearness Relief/2020-21/1037 1130 dated 11-11-2020, it is requested to make necessary arrangement for payment of dearness relief @ 256%, 264%, 268%, 274%, 284%, 295% and 312% to all eligible Haryana Government pensioners/family pensioners on their basic pension/family pension and Dearness Pension/Dearness Family Pension with effect from 01-07-2016, 01-01-2017, 01-07-2017, 01-01-2018, 01-07-2018, 01-01-2019 and 01-07-2019 respectively after proper adjustment.
