Subject : Grant of Temporary Increase (dearness relief) to the Gujarat Government pensioners/family pensioners on their pre-revised pension/family pension with effect from 01-07-2018 and 01-01-2019.

In continuation to this office circular No. Pen.Co-ordn./Gujarat/Vol.-V/DR-Pre-rev/21 dated 06-05-2019, this is to state that the Government of Gujarat in their F D Resolution Nos. HGV-102017-O-1201-P dated 07-09-2019 has sanctioned Temporary Increase (dearness relief) on pension/family pension of their pensioners/family pensioners drawing pension/family pension as per 6th Pay Commission (this office circular No. Pen.Co-ordn./Gujarat/Vol.-V/Revision/72 dated 25-08-2009), as under :

<i>Date of effect</i>	<i>Rate of Temporary Increase per month</i>
01-07-2018	148% of basic pension/family pension
01-01-2019	154% of basic pension/family pension

2. Temporary Increase at the rates indicated in above table will also be admissible on the additional basic pension/family pension available to older pensioners/family pensioners based on their age.


3. Payment of Temporary Increase involving a fraction of a rupee shall be rounded off to the next higher rupee.

4. Other provisions governing grant of Temporary Increase to pensioners such as regulations of dearness relief during employment/re-employment, regulation of Temporary Increase, where more than one pension is drawn etc. will remain unchanged.

5. Having been authorised by the Principal Accountant General (A&E), Gujarat in their letter No. Pension/G.R./Special Seal/GR-01/2019-20/OW No. 912 dated 14-10-2019, it is requested to make necessary arrangement for payment of Temporary Increase to all eligible Gujarat Government pensioners/family pensioners on their pre-revised basic pension/family pension @ 148% and 154% with effect from 01-07-2018 and 01-01-2019 respectively after proper adjustment.

6. The charges on this account are debitable to the head "8793-I.S.S. A/es.; Government of Gujarat etc."
