Promotion being granted to above officials will be on the following terms and conditions:

- i. Such officials from above list who have already taken over the charge as Supervisor on the due date mentioned against their names need not submit their joining again. Their date of promotion will remain the same.
- ii. Such officials from the above list who have refused promotion as Assistant Supervisor or not submitted declaration of deemed acceptance of promotion as Assistant Supervisor will be deemed to have refused promotion as Supervisor and their promotion in this cadre will be treated as null and void.

- Officials who have not taken over the charge of regular promotion as Supervisor will be granted notional benefits w.e.f. the dates mentioned against their names and the actual benefits will be granted to them from the date of taking over the charge as Supervisor.
- iv. The provisional promotion is being granted to those officials who have not successfully completed the mandatory training of Assistant Supervisor. The provisional promotion is subject to the condition that they have to successfully complete the training within two opportunities to be provided during the panel year 2021 itself failing which they will be reverted to the post of Sr. Accountant on the day of the declaration of the results of the second training. Subsequent to reversion, their pay will be fixed at the stage they would have drawn had they continued as Sr. Accountant.
 - v. The officials promoted provisionally will perform the duties of the post held by them in provisional capacity.
 - vi. Officials whose names are mentioned at Sl_No. 2 retired on 28.02.2021 and Sl_No. 7 & 14 retired on 31.01.2021. As such, their pension will be revised after notional fixation of their pay w.e.f. the date of promotion as mentioned against their names. Actual benefits of revised pension will be granted from the date of issue of this order.
 - vii. The pay of the officials promoted to Supervisor cadre in quick succession on the same date (i.e. 01.01.2021) will be regulated in terms of CAG decisions (4) under FR 22.

They will have the option, if applicable, for choosing the date of fixation of pay under FR-22 (I) (a) (I) on promotion to the post of Assistant Supervisor in accordance with Government of India M/O Home Affairs, Department of personnel & Administrative Reforms O.M. NO. F. 7/1/80/-Estt. P.I. dated 26.09.1981 read with Resolution No. 01-2/2016-IC dated 25.07.2016 of GoI, Ministry of Finance (Department of Expenditure).

The option has to be exercised within one month from the date of issue of this order. The option once exercised shall be final.

This office order supersedes the office orders issued regarding promotion in Supervisor cadre on 18.12.2020, 24.12.2020, 30.12.2020 and 28.01.2021.
