Sub:- Amendment in Para 9.8.2 of CAG's MSO (Admn) Vol I regarding incentive examination for Sr. Auditors

As per Headquarters Office Letter No. 624-staff (App-I)/13-2021 dt. 30.03.2021. Senior Auditors with one year continuous service in the grade on the first of the month in which the examination is scheduled to be held and Assistant Supervisor (Audit) who has not passed the examination while serving as Senior Auditor/Senior Accountant will be eligible to appear the Incentive Examination.

Hence, in partial modification to this office circular issued vide Memo No 447 dt 11.07.2021 applications are invited from the Assistant Supervisor(s) in level-7 of Pay Matrix who have not passed the incentive examination while serving as Sr. Auditors intending to appear the incentive examination for Sr. Auditors proposed to be held in April 2021.
