Sub: Additional chances to pass RA/I/CPD-I & CPD-II Examinations - reg.

In continuation to this office OOC No. 19 dated 07.04.2021 inviting applications from eligible fresh / repeater candidates intending to appear at the ensuing SAS/IE/CPD Examination-I scheduled to be held in June 2021. In this connection Examination Wing of Headquarters Office has communicated in Circular No. 03 of 2021 issued vide letter No. 159/03-Exam/Addl. Chance/2016 Vol.I dated 13.04.2021 that as a result of COVD-19 pandemic, Incentive / CPD-I & CPD-II could not be held for the year 2020.

In view of the above situation, the Competent Authority has permitted to avail two additional chances as a one time opportunity to existing candidates of RA/I/CPD-I & II Examinations who have exhausted all permissible six chances but could not clear the Examination. These two additional chances should be availed in four Examinations w.e.f Examination-1 of 2021 during two years i.e. 2021 and 2022.

Hence, all the eligible candidates who have exhausted all permissible six chances but could not clear the above Examination(s) and are willing to avail one of the two additional chances starting with Examination 1 of 2021 may apply by downloading the applications form(s) as applicable from the link provided in the notice issued earlier.
