Subject: Disciplinary action against Senior Accounts Officer and Senior Audit Officer after classification of their posts as Group 'A'

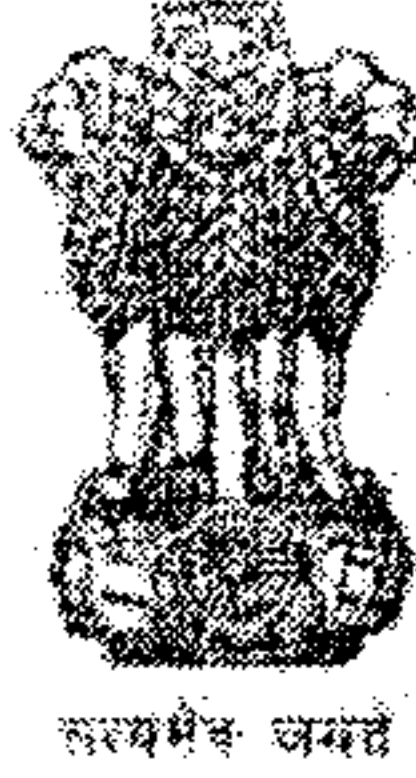

Subject: - Disciplinary action against Senior Accounts Officer and Senior Audit Officer after classification of their posts as Group 'A'.

Sir/Madam

A reference is invited to this office circular No. 44/Staff(Disc-II)/28-2019 issued vide No. 194/Staff(Disc-II)/28-2019 dated 21.10.2019 on the above mentioned subject whereby all concerned were advised: (i) to await further directions regarding delegation of powers of the Appointing/Disciplinary and the Appellate Authorities in respect of the posts of Senior Audit Officer and Senior Accounts Officer by order of the President after their classification as Group 'A'; (ii) to continue the inquiry proceedings in cases of initiation of disciplinary proceedings prior to classification of these posts as Group 'A' on 16.05.2019 till submission of inquiry reports; and (iii) to await further direction for subsequent action in such cases of submission of inquiry reports and for initiation of fresh disciplinary action pending delegation of powers with the exception of urgent and time bound matters, if any.

2. Delegation of powers through a Presidential order is likely to take some more time. Therefore, it has been decided by the Comptroller and Auditor General of India that all the matters pertaining to the disciplinary action against the Senior Accounts Officers, Senior Audit Officers and Senior Divisional Accounts Officers, all Group 'A' posts in General Central Service in Level 10 of the Pay Matrix in the IA&AD, shall be considered by him in the capacity of the Disciplinary Authority, as applicable to the IA&AS officers, till delegation of powers through a Presidential order is made.

3. In view of the above, it is requested that all the matters pertaining to disciplinary action against Senior Accounts Officers, Senior Audit Officers (other than Commercial) and Senior Divisional Accounts Officers may be sent to the Staff Wing in this office along with all the relevant material for submission to the CAG of India for his consideration and decision. The cases of the Senior Audit Officers (Commercial) are to be sent to the Director General (Commercial) as per present practice for similar action.
