विषय :-SAS Part-I & II/RA/I/CPD- I, II & III, Examination-I, 2021-regarding.

HQ office, vide letter No. 143/03-Exam-I 2021 dated 01.04.2021 has intimated that Examination-I of SAS/RA/I/CPD-I, II & III 2021 will be held from 14/06/2021 to 19/06/2021. Vide Circular No.11 of 2020 Letter No. 75/03-Exam/Addl. Chance/2016/Vol.-I dated 19th October 2020, the number of chances to pass **SAS Examination** have been increased from 10 to 12. The details of the modified system are under-

- a) Under the modification system, the total chances to pass the SAS Examination will be **twelve** (6 normal +6 additional)
- b) The time limit for passing the SAS Examination will be eight years considering two Examinations in a year (**8 years for 12 chances**). The six additional chances are not consecutive as earlier,
- c) The additional six chances will be admissible only to those candidates who have cleared five papers within first (normal) six attempts.
- d) Those who have already exhausted ten chances will be allowed two more chances from next SAS Examination-I and has to avail these two chances within two years i.e. four Examinations (counting from Examination-I of 2021).
- e) The eligible officials will be allowed to appear **afresh** in the SAS Examination after exhausting either twelve chances or eight years whichever is earlier from the first registration of CBT **without carry forwarding exempted papers**.
- f) The eligible officials who could not pass five papers within the first (normal) six chances will also be allowed to appear **afresh** in the SAS Examination **without any carry forward exempted papers** (no need to wait for completion for eight years).
- g) **Afresh** means that the candidates are required to be screened through the Preliminary Test, mandatory training etc. as applicable to the candidates appearing for the first time
- h) In the modified system also, chance will be counted once a candidates registers for SAS Examination.
- i) There would be no scope for withdrawal of candidature under modified system.
- j) In respect of direct recruit AAOs, they have to qualify the SAS Examination in respective branches during the period of probation for confirmation and regular appointment as AAO.
- k) The modified system including the counting of eight years of SAS Examination will be applicable from next SAS Examination – I of 2021.

RA/CPD Examination

Vide Circular No.03 of 2021 letter No. 159/03-Exam/Addl Chance/2016 Vol. I Dated 13th April 2021, Headquarter has permitted to avail **two additional chances** as a one-time opportunity to existing candidates of RA/I/CPD-I&II Examinations who have exhausted all permissible six chances but could not clear the Examination.

These **two additional chances** should be availed in four Examinations w.e.f. Examination-I of 2021 during two years i.e. 2021 & 2022.

As such, eligible candidates who intend to appear in the SAS/CPD-I, II & III Examination-I of 2021 may submit their application (along with one latest photograph) in the prescribed proforma (attached herewith) through email at monicak.del.esm@cag.gov.in / dayas.del.esm@cag.gov.in or hard copy in **Confidential Cell latest by 27.05.2021 strictly.**

The candidates who intend to appear in the RAE first time, may submit their application latest by 20.05.2021 strictly (also mark RAE Fresh Candidates). Incomplete applications or applications received after the specified date shall not be entertained.

The intending candidates for the aforesaid examinations may please note carefully that each registration is counted as one attempt. Thus, only candidates who are prepared to take the examination should register for the examination. Withdrawal of candidature is not permissible, once the candidate is registered.
