#### **ADVISORY IN VIEW OF CYLCONE "YAAS"**

Hurricane-force winds Cyclone "YAAS' and heavy rainfall expected along the Bay of Bengal Coast and offshore. As per report of IMD, it is very likely to move north-northwestwards and cross Odisha Coast between Paradip and Sagar Deep, during 26 May afternoon with maximum sustained wind speed of 155-165 Kmph gusting to 180 Kmph. The Estate Cell of this office is co-coordinating with CPWD in this regard as an alternative measure for emergency. Further, the concerned Administrative section of all the four offices will ensure the storage of drinking water/normal water in office for emergency. In addition to the above, all the staffs are requested to follow the following advisory during the disaster period:-

- (a) Ask people to IGNORE rumors and STAY CALM and not to be panic before the cyclone,
- (b) KEEP their mobile phones CHARGED to ensure connectivity; use SMS,
- (c) LISTEN to radio, watch TV, read newspapers for weather updates,
- (d) Prepare an EMERGENCY KIT with essential items for safety and survival,
- (e) People SHOULD NOT leave sharp objects lose,
- (f) Cattle and animals should also be UNTIED to ensure their safety,
- (g) While, during and after the cyclone, people have been advised to:
  - SWITCH OFF electrical mains
  - Drink BOILED AND CHLORINATED water
  - AVOID entering into damaged houses during and after the cyclone,
- (h) Avoid riding of Vehicles, cycle etc., during the entire cyclone period and stay in a safe place and also advise your family members regarding safety measures.

It is also requested that this may be widely circulated among the staffs.
