Their appointment as AAO (Adhoc) will be subject to the following conditions:

- (a) They will not be given full supervisory charge. They will continue to discharge the same functions and duties as discharged by them while holding the current post. However, they may be given task of more arduous nature involving greater analytical skills and may be assigned workload that is substantially higher than existing norms for their present post.
- (b) The service rendered by them as AAO (Adhoc) will not be counted as regular service in AAO cadre for the purpose of seniority, promotion, eligibility for appearing in Departmental Examination (i.e. incentive examination/CPD examination etc.) or for any other entitlement. However, it will be counted for financial upgradation under MACP Scheme.
- (c) Appointment on Adhoc basis is purely a stop-gap arrangement and such Adhoc appointment can be reviewed and if circumstances so warrant, they may be reverted to their substantive post.

They may exercise the option for choosing the date of fixation of pay under FR 22 (I) (a) (I) on appointment to the post of Asstt. Audit Officer (Adhoc) in accordance with Government of India M/O Home Affairs, Department of Personnel & Administrative Reforms O.M. No. F,

The option has to be exercised within one month from the date of joining as Asstt. Audit Officer (Adhoc). The option once exercised shall be final.
