In terms of the Headquarters' Examination Section letter bearing no 191/03-Exam/Examination-I/2021 dated 28.05.2021, the Online Registration for SAS/RA/I/CPD-I,II & III Examinations of Examination-I of 2021 will commence from 07.06.2021. The dates and schedule of the examination will be intimated in due course

Fresh candidates for SAS/I/CPD-I,II & III Examinations of Examination-I of 2021 are instructed to email their duly filled in Pre-Registration Form to email ID - pritishb.wbl.ae@cag.gov.in on or within 11.06.2021. The basic data of fresh candidates will be entered by the Office as mentioned in the Service Books. Thereafter, the fresh candidates will complete second part of the Registration Form by themselves. The existing candidates will fill up the second part of the Registration Form by directly. The link for registration is https://cagi.azurewebsites.net.

However, in respect of fresh DA cadre candidates, the Pre-Registration Form may please be routed through Sr.AO/WM. The applications/ Pre-registration Forms may be sent to email ID **pritishb.wbl.ae@cag.gov.in** on or within 11.06.2021.

The officials who are on deputation to other offices may submit their applications directly through email with email ID – **pritishb.wbl.ae@cag.gov.in** under intimation to Administration of the borrowing offices on or within 11.06.2021.

The eligibility criteria for appearing in the CPD-I, II & III Examinations and Incentive Examination are provided overleaf:-

## CPD Test:-

- All Sr AO Sr DAO's are eligible to appear for CPD-I Test. AAO/ DAO-I/
  shall be eligible to appear in the CPD-I Test after completion of four years' continuous
  service in the grade
- The CPD-II Test can be taken by Sr. AO/AAO/Sr.DAO/ DAO-L after completion of four years from qualifying CPD-I Test.
- 3 Sr AO/AAO/ Sr DAO/DAO-I/ are eligible to appear CPD-III Test after completion of 3 years from qualifying CPD-II Test.

## Incentive Examination:-

All Sr AO/ Sr. DAO's are eligible to appear in the Incentive Examination. AAO/ DAO-I/
are eligible to appear for Incentive Examination after completion of 1 year continuous
service in the grade.

In terms of Headquarters Examination Wing Circular No. 3 of 2021 dated 13.04.2021, as a result of COVID-19 pandemic, Incentive/CPD-I&II Examinations could not be held for the year 2020

Keeping in view of the above situation, the Competent Authority has permitted to available additional chances as a one-time opportunity to existing candidates of Incentive/ CPD-I&II Examinations who have exhausted all permissible six chances but could not clear the examination. These two additional chances should be availed in four examinations w.e.f. Examination-1 of 2021 during two years, i.e. 2021 & 2022.

Regarding number of permissible chances to pass the SAS Examination, candidates are requested to go through Headquarters Examination Wing Circular No. 11 of 2020 dated 19.10.2020 circulated vide this Office Order No PAGAEWB/02/02/189/130 dated 27.10.2020.

It is also requested to take note of the circulars, revised syllabus and other materials being uploaded on the CAG's website from time to time
