The terms and conditions of appointment as Assistant Audit Officer (Ad hoc) in respect of the above mentioned officials are as follows:

1. The officials appointed as AAO (Ad hoc) may be assigned duties as decided by the Heads of Department, while ensuring that they are not given full supervisory charge.
2. The newly created AAO (Ad hoc) posts will not be taken into account for determining the posts of Supervisors.
3. The AAO (Ad hoc) posts will lapse on the regularization of incumbents as AAO. Consequently, the posts currently held by them against the AAO (Ad hoc) will also be deemed to have been released.
4. The service rendered on Ad hoc basis will not count as regular service in AAO cadre for the purpose of seniority, promotion, eligibility for appearing in departmental examination (i.e. incentive examination/CPD examination etc.) or for any other entitlement. However, it will be counted for financial up-gradation under MACPS.
5. Appointment on Ad hoc basis is purely a stop-gap arrangement pending filling up of the post on regular basis and such Ad hoc appointment can be reviewed and persons reverted to his substantive post, if circumstances so warrant.

Above officials may exercise the option for choosing the date of fixation of pay under FR 22 (1) (a) (I) on appointment to the post of Assistant Audit Officer (Ad hoc) in accordance with Govt. of India, Ministry of Home Affairs, Dept. of Personnel & Administrative Reforms OM No. F 7/1/80 Estt-P.I. – dated: 26.09.1981 read with resolution No. 01-2/2016-IC dated 25.07.2016 GOI, Ministry of Finance, Dept. of Expenditure.
