It is hereby notified that Divisional Accountants' Grade Examination (September) 2021 is proposed to be held during the month of September 2021. The detailed programme with the dates and venue of the examination will be notified in due course.

Application containing the particulars (ANNEXURE-I) from candidates who have already completed or will complete 3(three) years of service as Sr. Accounts Clerks, and 1(one) year of service as Divisional Accountant (Probationer) as on 01.09.2021, duly forwarded by their Divisional Officers may be sent by e-mail or Registered post so as it will reach the Deputy Accountant General (A/cs & VLC), O/o the Pr. Accountant General (A&E), West Bengal, Treasury Buildings, Kolkata-1 latest by 20.08.2021.

Under no circumstances applications received after the said date will be entertained.

The last date for withdrawal of candidature for the aforesaid examination is 24.08.2021.

Applications of only those candidates who fulfill conditions laid down in chapter VII of the C & AG's M.S.O. (Admn.), Vol-I would be recommended.

It may be noted that every candidate appearing in this examination must be a Sr. Accounts Clerk appointed by this office after passing the Initial Recruitment Examination for Divisional Accountants or Divisional Accountant (Probationer) appointed by Staff Selection Commission. Divisional Accountants (Probationer) have to appear in all the following five papers & Sr. Accounts Clerks have to appear in four papers from (ii) to (v) in the list given below, if not already exempted from appearing in any of them.

Unless otherwise communicated, the candidates should answer questions in the D.A.G.E. with reference to the new Heads of Accounts.

i) Essay or Précis and Draft & Grammar [only for Divisional Accountant (Probationer) who have completed 1 year service]

- ii) Elementary Book Keeping
- iii) Public Works Accounts and Procedure (Theoretical)
