**Subject :- Grant of dearness relief on pre-revised pension/family pension to the pensioners/family pensioners(teaching/non-teaching )of Non Govt. Colleges w.e.f. 1.1.2021**

In continuation to this office circular No. Pen.Co-ordn./51/Vol-VI/204/Vol-II/142 dated 31/10/2018 followed by Pen.Co-ordn./51/Vol-VI/204/Vol-II/126 dated 05/02/2021, it is stated that the Govt. of West Bengal Higher Education Department, C.S. Branch in their order no. 208-Edn(CS)/1P-1/2013, dated 05/02/2021 have sanctioned dearness relief @ 133% with effect from 1/1/2021 to the pensioners/family pensioners of the teaching and non-teaching staff of the State-Aided Non-Government Colleges, who are still drawing pre-revised pension/family pension as per ROPA 2009.

Payment of dearness relief on pension/family pension involving a fraction of rupee shall be rounded off to the nearest rupee in each case.

All concerned Pension Disbursing Officers are, therefore, requested to allow dearness relief on un-revised rates of pension/family pension @ 133% with effect from 1/1/2021 to the above categories of pensioners/family pensioners till their pension/family pension is revised.

Other provisions governing grant of dearness relief to the pensioners/family pensioners not mentioned in this order, such as regulation of relief during re-employment, regulation of relief where more than one pension is drawn etc., will remain unchanged.

Accountants General of other States are requested to arrange extra copies of the said Govt. order at their end, if necessary, for circulation within their State.
