Subject :- Grant of dearness relief on pension/family pension to the pensioners/family pensioners(teaching/non-teaching) of Non Govt. Colleges w.e.f. 1.1.2021

In continuation to this office circular No. Pen.Co-ordn./51/Vol-VI/204/Vol-II/142 dated 31.10.2018, it is stated that the Govt. of West Bengal in their Higher Education Department, C.S. Branch in their order no. 172-Edn(CS)/1P-1/2013, dated 28.01.2021 have sanctioned dearness relief @ 3% with effect from 1/1/2021 on the revised basic pension/family pension which are revised in terms of Memo No. 210-Edn (CS) dated 14/02/2020 or Memo No. 214-Edn (CS) dated 14/02/2020 respectively, (circulated under this office circular No. Pen. Co-ordn./204/Vol-II/198 dated 17/03/2020 and Pen. Co-ordn./204/Vol-II/197 dated 17/03/2020 respectively) to the pensioners/family pensioners of the teaching and non-teaching staff of the State-Aided Non-Government Colleges in this State.

All concerned Pension Disbursing Officers are, therefore, requested to allow dearness relief on revised rates of pension/family pension @ 3% with effect from 1/1/2021 to the above categories of pensioners/family pensioners.

Payment of dearness relief on pension/family pension involving a fraction of rupee shall be rounded off to the nearest rupee in each case.

Other provisions governing grant of dearness relief to the pensioners/family pensioners not mentioned in this order, such as regulation of relief during re-employment, regulation of relief where more than one pension is drawn etc., will remain unchanged.

Accountants General of other States are requested to arrange extra copies of the said Govt. order at their end, if necessary, for circulation within their State.
