Subject : Grant of dearness relief to Assam Government pensioners/family pensioners/extra-ordinary pension holders with effect from 01-07-2021.

In continuation to this office circular No. Pen. Co-ordn./Assam/Vol.-VIII/DR/123 dated 03-12-2019, this is to state that the Government of Assam in their O.M. No. FEG.08/2017/95 dated 18-08-2021 have sanctioned dearness relief to their pensioners/family pensioners/extra-ordinary pension holders as under :

<i>Date of effect</i>	<i>Rate of dearness relief per month</i>
01-07-2021	28% of basic pension/family pension

2. The payment on account of dearness relief involving fraction of 50 paise and above may be rounded off to the next higher rupee and fraction of less than 50 paise may be ignored.

3. Having been authorized by the Principal Accountant General (A&E), Assam in their letter Nos. GE-1/State/DA/2021-22/278 - 300 dated 19-08-2021 and Pen-3/T-01/Assam/DR/OAC/Vol-VI/2020/311 - 345 dated 13-09-2021, it is requested to make necessary arrangement for payment of dearness relief @ 28% to all eligible Assam Government pensioners/family pensioners/extra-ordinary pension holders with effect from 01-07-2021 after proper adjustment.

4. The charges on this accounts are debitable to the head "8793-I.S.S.A/cs.; Government of Assam etc."
