with effect from 01-01-2017, 01-07-2017, 01-01-2018,
01-07-2018, 01-01-2019, 01-07-2019 and 01-07-2021.

In continuation to this office circular No. Pen. Co-ordn./Jharkhand/DR/215 dated 14-03-2017, this is to state that the Government of Jharkhand in their FD Resolution Nos. Be.Pra. 6A - 12/2013/2750/B. dated 21-08-2017, Be.Pra. 6A - 12/2013/3684/B. dated 17-11-2017, Be.Pra. 6A - 12/2013/1230/B. dated 25-05-2018, Be.Pra. 6A - 12/2013/452/B. dated 21-02-2019, Be.Pra. 6A - 12/2013/1868/B. dated 11-07-2019, Be.Pra. 6A - 12/2013/1868/B. dated 13-05-2020 and Be.Pra. 6A - 12/2013/1923/B. dated 26-08-2021 have sanctioned dearness relief on un-revised pension/family pension of their pensioners/family pensioners at the rate from the date as under:

Date of effect	Rate of dearness relief per month
01-01-2017	136% of basic pension/family pensin
01-07-2017	139% of basic pension/family pensin
01-01-2018	142% of basic pension/family pensin
01-07-2018	148 % of basic pension/family pensin
01-01-2019	154% of basic pension/family pensin
01-07-2019	164% of basic pension/family pensin
01-07-2021	189% of basic pension/family pension

- 2. Dearness relief as above will also be admissible to the civil pensioners who are entitled to receive compensation/old age/disabled pension. Relief will also be admissible to the pensioners who are in receipt of provisional/family/extra ordinary pension.
- 3. Payment of dearness relief involving fraction of 50 paise and above shall be rounded off to the next rupee and fraction less than 50 paise shall be ignored.
- Having been authorized by the Accountant General (A&E) Jharkhand in their letter No. PEN-III/Jharkhand/DR/2017-18/2010 (SSA No. 99/2017-18) dated 11-12-2017, PEN-III/Jharkhand/DR/2018-19/559 07-06-2018. III/Jharkhand/DR/2020-21/ No. 39/20-21) (SSA dated 20-01-2021 and PEN-III/Jharkhand/DR/2021-22/1515 (SSA No. 29/2021-22) dated 18-09-2021, it is requested to make necessary arrangement for payment of dearness relief @ 136%, 139%, 142%, 148%, 154%, 164% and 189% to all eligible Jharkhand Government pensioners/family pensioners on their pre-revised pension/family pension with effect from 01-01-2017, 01-07-2017, 01-01-2018, 01-07-2018, 01-01-2019, 01-07-2019 and 01-07-2021 respectively after proper adjustment.
