#### OFFICE ORDER

Subject: Applications for SAS /RA/CPD-I/CPD-II/CPD-III for Examination-2 of 2021.

Applications for SAS/RA/CPD-I/CPD-II/CPD-III Examination-2 of 2021 are invited from Officers/Officials of the following categories:

### 1. SAS - Group I & II Examination (Civil and Commercial):

- (1) Candidates who have appeared in SAS Examination-1 of 2021 or earlier, but failed to qualify.
- (2) Repeaters who have not exhausted six chances.
- (3) Repeaters who have exhausted all the six chances and secured exemption in/passed atleast five papers of SAS examination can apply subject to the limit of maximum 12 attempts.
- (4) Fresher Departmental candidates who have passed SAS Prelims examination held during April-2021, who would be completing their probationary period on or before 01.09.2021.

### 2. Revenue Audit Examination (Civil and other than Civil)

- (1) Candidates who have appeared in RA Exam of Examination -1 of 2021 or earlier, but failed to qualify. (subjected to the limit of maximum 8 chances)
- (2) Fresher who have completed one year continuous service as Assistant Audit Officer as on 01.09.2021.

## 3. <u>Continuous Professional Development (CPD)-I Examinations</u> (Civil and Commercial)

- (1) Candidates who have appeared in CDP-I Exam of Examination-1 of 2021 or earlier, but failed to qualify. (subjected to the limit of maximum 8 chances)
- (2) Freshers All Sr. Audit Officers.
- (3) Freshers All AAOs including AAOs (RT) who have completed **four years** continuous service as AAOs as on **01.09.2021**.
- (4) Freshers All directly recruited AAOs who have completed **four years** of regular service from the date of confirmation as Assistant Audit Officer

## 2. <u>Continuous Professional Development (CPD)-II Examinations</u> (Civil and Commercial)

- (1) Candidates who have appeared in CDP-II Exam of Examination-1 of 2021 or earlier, but failed to qualify (subjected to the limit of maximum 8 chances).
- (2) Freshers All candidates after completion of four years i.e. as on 01.09.2021 from qualifying their first CPD-I examination are eligible to appear for CPD-II examination.

## 3. <u>Continuous Professional Development (CPD)-III Examinations</u> (Civil and Commercial)

- (1) Candidates who have appeared in CPD-III Exam of Examination -1 of 2021 or earlier, but failed to qualify. (subjected to the limit of maximum 8 chances)
- (2) Freshers All candidates after completion of three years from qualifying their CPD-II examination are eligible to appear for CPD-III examination.
- 4. Hindi is allowed to be used as alternative medium to English for answering papers of Group I and Group II of Civil and Commercial Audit Branches. The option to use **Hindi medium** should be indicated in the application form for admission to the examination. Option once exercised shall be final and the candidates will not be permitted to answer papers partly in Hindi and partly in English.
- 5. Applications for SAS/RA/CPD-I/CPD-II/CPD-III examinations should be submitted to Admn-II/ Audit-I section. Officers/ Officials appearing for SAS examination working in field may send their applications duly recommended by the respective Branch Officers of Controlling Sections to Sr.Audit Officer (Admn)/Audit-I by name.
- 8. The last date for receipt of application in Admn-II/AUDIT-I section is **08.12.2021 (Wednesday)**. Applications received after the due date will not be considered strictly.

- 9. Officers/Officials who do not submit their application before the due date would not be allowed to register for the examination later.
- 10. Applications should be complete in all respects. Incomplete applications and those not submitted within the due date are liable to be rejected.
