The Accountant General (A&E) is pleased to promote the Divisional Accountants (Group B – Non-Gazetted) listed in the Annexure as Divisional Accounts Officers Grade II (Group B – Non-Gazetted) in level 7 of Pay Matrix under CCS Revised Pay Rules 2016 with effect from 03/01/2022 FN or from the date of taking over charge as Divisional Accounts Officer Grade II, whichever is later.

If the official is on leave/ deputation/ foreign service etc., the promotion will take effect from the date of re-joining duty and taking over charge of the higher post.

If the promoted officials desire to have their pay fixed in the post of Divisional Accounts Officer Grade II from the date of their next increment in the lower post under the provisions of FR 22 I (a)(1), option in this regard should be exercised within a month from the date of promotion. The option once exercised will be final.


