- 2. The term of deputation will be initially for three years and extendable thereafter on yearly basis subject to the continued suitability of the official and administrative convenience of this office.
- 3. The application of officers willing to serve in RTI, Ranchi in the abovementioned capacity may kindly be forwarded along with the following documents latest by 13.01.2022.
  - a) Particulars of applicants (Bio-data) in enclosed format duly attested by head of office
- b) Vigilance clearance Certificate: It may be certified that no Disciplinary/Court/Vigilance case is pending or contemplated against the applicant

Further, a reference may be invited to Headquarters circular No 269/Trg Div/42-A/2019 dated 18.09.2019 wherein detailed instructions to the field offices on augmentation of staff in RTIs/RTCs(Administration and Faculty) have been issued for strict compliance. The instructions in said circular are reproduced below:

- (i) Field offices shall display the deputation notification issued by RTI on the notice boards and circulate among the staff giving reasonable time to the candidates for responding to the notification
- (ii)Field offices shall forward all applications received from their offices/staff against the post advertised by RTIs/RTCs to the concerned Institute/Centre, without withholding any application.
- (iii) On completion of selection process, the field offices shall obligatorily relieve the selected officials for teaching/administrative assignment at RTIs/RTCs at the earliest.
- (iv) The initial deputation period to RTI/RTC will be three years however, reserves the right to repatriate a deputationist at any time, if his/her performance is found unsatisfactory.
