CIRCULAR

Sub Calling for applications / willingness from eligible fresh / repeater candidates intending to appear at the ensuing CPD-I and CPD-II Examination-I of 2022 tentatively scheduled to be held in April 2022.

It has been decided by Headquarters Office to provide Pre-Examination Training to Sr. DAOs / DAOs-I for CPD Examinations to be held in April 2022 and onwards. In this connection Training Wing of Headquarters office has firmed up an action plan for pre-examination online training for CPD papers involving in-house and external training partners.

The proposed online training programme for all papers of CPD-I, CPD-II and CPD-III Examinations which is tentatively scheduled to start from 31st January 2022 on a batch wise basis for willing and eligible Sr. DAOs / DAOs-I for different levels of CPD Examinations. In this connection in order to facilitate the proposed training to all the eligible officers of this office, it has been scheduled to shortlist the names of all such officials who will be eligible for both CPD-I, CPD-II and CPD-III Examination-1 of 2022 schedule to be held in April 2022 onwards, may submit their willingness in the prescribed pro-forma by downloading the same from the link provided

The Sr. DAOs / DAOs-I fulfilling the following criteria are eligible for the proposed training.

- i. The scheme of pre-examination training will be applicable from CPD Examination-I of 2022 and onwards
- ii. The scheme of pre-examination training is for all **Sr. DAOs / DAOs-I** who intend to appear in CPD examinations to be held from April 2022 and onwards.
- iii. The pre-examination training for each paper of CPD Examination will be provided only once, irrespective of whether the candidate appears in the CPD Examination or not.
- iv. The training completion certificate will have to be mandatorily sent to Examination Wing and Training Wing, Headquarters.
- v. Nomination and registration of participants for the pre-examination training should be done through SAI Training Application only.
- vi. Pre-examination training for CPD examination is **not** mandatory for appearing in the CPD Examination of 2022 and onwards.
- vii. All **Sr. DAOs / DAOs-I** who intend to appear for the CPD examination I and CPD examination-II of 2022, will be provided the said training. However, pre-examination training of CPD examination 2022 will be conducted only once for CPD Examination-1 and Examination-2.

The following Sr. DAOs / DAOs-I are eligible for taking the proposed training and appear the CPD-I Examination scheduled to be held in April 2022.

- 1. All Sr. DAOs are eligible to take the first CPD test.
- All DAOs-I would be eligible to appear in the first CPD test after completion of four years continuous service in the grade as on the 01.03.2022 / 01.09.2022 as the case may be.

Similarly, the following Sr. DAOs / DAOs-I are eligible for taking the proposed training and appear the CPD-II Examination scheduled to be held in April 2022.

All Sr. DAOs / DAOs-I who have completed four years as on 01.03.2022/01.09.2022 as the case may be, since the date of their qualifying the CPD-I Examination.

Further, in terms of Headquarters office Exanimation Wing Circular No. 10 of 2020 issued vide 370/04-Exam/MSO/Chapter 9 of Revision/2020 dated 15.09.2020, Circular 11 of 2020 issued vide No. 75/03-Exam/Addl. Chances/2016/Vol/I dated 19.10.2020 and Circular No. 03 of 2021 issued vide letter No. 159/03-Exam/Addl. Chance/2016 Vol.I dated 13.04.2021 applications in the prescribed proforma (enclosed) are invited from eligible fresh / repeater candidates intending to appear **CPD Examination-I of 2022**.

The intending candidates are requested to follow revised Chapter IX of MSO (Admn) Vol.I for eligibility criteria for appearing the SAS/IE/CPD Examinations. Apart from this, Headquarters Office Examination Wing Circulars issued in this regard may also be referred for the purpose.

Hence, all eligible Sr. DAOs / DAOs-I of the Office of the Accountant General (A&E), Odisha, Bhubaneswar of Branch Office, Puri intending avail the proposed training program and appear the above examinations scheduled to be held from April 2022 onwards may submit their willingness / application duly filled in the prescribed pro-forma through proper channel on or before **28.01.2022**. The application form can be downloaded from the office website (https://cag.gov.in/ae/odisha/en/ae-circulars-office-orders?cat=853). Applications received after due date or in incomplete shape will be rejected.
