CIRCULAR

Sub - Calling for applications from fresh / repeater candidates intending to appear in SAS/RA/CPD-I, II & III Examination-1 of 2022.

In terms of Headquarters office Circular No. 10 of 2020 issued vide No 370/04-Exam/MSO Chapter 9-Revision/2020 dated 15.10.2020, Circular 11 of 2020 issued vide No-75/03-Exam/ Addl chances/2016/ Vol- I, dated-19.10.2020 applications in the prescribed proforma (enclosed) are invited from eligible fresh / repeater candidates intending to appear SAS/RA/CPD-I&II **Examination-1 of 2022**. The eligible candidates who have put in a minimum of 2 years of continuous service in a particular field office and has successfully completed their probation period are eligible to appear in the SAS Examination. **The cut off dates for determining the eligibility of the officials for SAS/RA/CPD I, II & III Examination will be 1st March 2022 for Examination 1 & 1st September 2022 for Exam-2 of 2022.** As per the Headquarters Examination schedule of 2022, the SAS/RA/CPD examinations will be held from **18th to 23rd April 2022**.

Further the requisites for number of permissible chances to pass the SAS Examination has been mentioned in Examination Wing Circular 11 of 2020 issued vide No-75/03-Exam/ Addl chances/2016/ Vol- I, dated-19.10.2020 and additional chances to RA/CPD-I&II examinations has also been mentioned vide Examination wing Circular No. 03 of 2021 dt. 13/04/2021.

The intending candidates are requested to follow the revised Chapter IX of MSO (Admn) I for determining the eligibility criteria for appearing the SAS/RA/CPD I & II Examinations. Further Headquarters Office Examination Wing Circulars issued in this regard may also be referred for the purpose.

The last date for receipt of applications in Trg & Exam section is **18/02/2022**. The fresh RA Candidates who will be eligible for Exam-2 of 2022 may also apply for attending pre examination training which will be conducted only once during the year. The application form maybe downloaded from the office website.
