As per the revised Chapter IX, para 9.4 of MSO (Admn) Vol.I, and the relaxed clauses of Column 11 and Colum 12 of the Schedule of Indian Audit and Accounts Department, Accountant Recruitment Rules 1986 further amended by GSR No. 200 dated 10.04.1990 method of recruitment to the post of Accountant, the following Graduate Group "C" officials with combined regular service of 3 years as on 01.02.2022 are eligible to appear the Departmental Examination for Accountants, February 2022.

- 2. DEOs (both Grade "A" and Grade "B")
- 3. Staff Card Driver(s).
- 4. Multi Tasking Staff (MTS)
- 5. Canteen Staff

Accountant General may at his discretion, condone deficiencies in the prescribed service, of three years in respect of Graduate Group "C" officials, up to a limit not exceeding two months.

The eligible candidates may submit their application to Admn.I Section, duly filled in, in the prescribed pro-forma which can be downloaded from the office website (https://cag.gov.in/ae/odisha/en/ae-circulars-office-orders?cat=853) latest by 15.02.2021.

Applications received after due date or in incomplete shape will be rejected.
