It is informed that the C&AG has desired that all the officials of IA&AD must be equipped with optimum functional knowledge in respect of following topics:

The Self-Learning Modules (SLMs) on these topics are available on the SAI Training portal as already intimitied vide Training Cell Circulars bearing No. Trg. Cell Circular/2021-22/07 dated 08.02.2022 and Trg. Cell/Circular/2021-22/740-46 dated 17.02.2022. All the officials including MTS, of this office are hereby directed to get well versed on the said topics by accessing the SLMs evailable on SAI Training Application and the same should be ensured by the respective Section to-charges/Branch Officers of the staff working under hem. In this regard. Section-In-charges/Branch Officers should furnish a report (attached as Annexure-I) to the Admn-III Section on or before 22.03.2022 positively.

Note: If any official is facing problem in accessing the SLMs on the SAL Training portal. Section-In-charge/Branch Officer of that section will ensure the access to that official. If the Section-In-charge/Branch Officer is also unable, he/she may contact the Training Cell of this office.

Further, it is informed that as per Pr. Account ant General orders dated 14 03.2022, an evaluation examination covering all the above mentioned topics (except SPARROW) will be conducted for all the employees of this office on 25.03.2022 which is mandatory for all. The salient features of the examination are as below:-

- 1. The Examination will be held online on Google Form on 25 03.2032 from 12.00 Noon to 01.00 PM. The link of Google Form will be provided in due course.
- 2. All the officials will take the examination on their respective sosts
- 3. The examination will be conducted under the surveillance of concerned Section-Incharge/Erranch Officer. The Section In-charge of each section is directed to ensure that each official under them take the examination. He/she is also responsible that link of the Google Form is available to every official, none of the official leaves their

seat during the examination, the officials start and submit the examination on time and all the officials fill all the details correctly. The Examination submitted after 01.00 PM will be treated as cancelled.

4. The Section-In-charge/Branch Officer of each section will furnish the Attendance-Sheet-cum- report regarding the examination (as attached in Annexure-II) to the Admin III section just after the examination on the same pay. The Sr. AOs should ensure that all the Section In-charge under them has furnished the said reports of Annexure-I&II.
