OFFICE ORDER

Examination wing of Headquarters' office, vide letter No. 158/13-Examination-I/2022 dated 29.03.2022 has intimated that the registration process for the SAS/RA/I/CPD-I, II & III Examinations in Examination-I of 2022 will commence on 1st April 2022 and will end on 18th April 2022. The dates and schedule of the examination will be intimated in due course.

The officials who are on deputation to other offices from this office will submit their applications in prescribed proforma directly to this offices under intimation to the borrowing offices. The number of chances for passing SAS/RAE/CPD exams had been amended, as circulated earlier. Modified system of Examination I & II has come into force. Under this system, Chances will be counted once registration is done and scope of withdrawal of candidature has been dispensed with. Some other salient features of the modified system are as under:-

SAS Examination (Ref:No.75 /03-Exam/Addl Chance/2016/ Vol. I dated 19 October 2020)

- The total chances to pass the SAS examination will be twelve (6 normal + 6 additional).
- The time limit to pass the SAS Examination will be eight years considering two Examinations in a year (8 years for 12 chances). The six additional chances are not consecutive as earlier.
- The additional six chances will be admissible only to those candidates who have cleared five papers within first (normal) six attempts.
- Those who have already exhausted ten chances will be allowed two more chances from SAS Examination – I and has to avail these two chances within two years i.e. four examination (counting from Examination – I of 2021).

RAE/CPD Examinations (Ref :No. 159/03-Exam/Addl Chance/2016 Vol. I Dated 13thApril 2021)

Competent Authority has permitted to avail **two additional chances** as a **one-time opportunity** to existing candidates of RA/I/CPD-I&II Examination who have exhausted all permissible **six chances** but could not clear the Examination. These **two additional chances** should be availed in **four Examinations w.e.f. Examination – I of 2021 during two years i.e. 2021 & 2022.**

Steps for Registration

After Pre-registration, registration process will start from 1st April 2022 through <http://cagi.azurewebsites.net> and will end on 18th April 2022. For fresh Candidates first part of the form will be filled by the Examination Registration Officer (ERO), thereafter the second part of the form will be completed by the candidates themselves. The existing candidates will fill up the second part of the registration form directly. The ERO will generate Login Id and OTP which will be received by each of the candidates through SMS and on email id provided by them.


In view of the above, the officers/officials who are in field and intend to appear in the SAS/RA/CPDI/CPD II/CPD III Examination – I of 2022 may submit their applications (in enclosed format) through email at trgexam1111@gmail.com or hard copy positively on the above mentioned dates.
