**CIRCULAR**

The Incentive Examination for Senior Accountants and Assistant Supervisors who have not passed the Incentive Exam as Sr. Accountant is scheduled to be held on **28-04-2022 between 11.00 A.M. to 01.00 P.M.**

The Senior Accountants in Pay Level 6 with one-year continuous service in the grade on the first of the month in which the exam is scheduled to be held i.e. as on 01-04-2022 are eligible to appear in the examination. Further, the Assistant Supervisors in Pay Level 7 who have not passed the Incentive Exam while serving as Senior Accountant are also eligible to appear for the examination. The candidates securing 50% marks and above would be granted one advance increment in their respective pay level of Sr. Accountant/Asstt. Supervisor with effect from the 1<sup>st</sup> of the month in which the examination is held i.e. as on 01-04-2022.

The examination will be held in objective mode of 100 question of one mark each. There will be one paper on "Finance, Accounts and Internal Audit" for a duration of **2 hours for 100 marks.**

The Syllabus of the Incentive Examination for Sr. Accountants is as follows:

- I. COMPTROLLER AND AUDITOR GENERAL'S (D.P.C.) ACT, 1971.
- II. INTRODUCTION TO INDIAN GOVERNMENT ACCOUNTS & AUDIT.
- III. CONSTITUTION OF INDIA
  - (a) PART V of the Constitution of India – THE UNION
    1. Money Bills and Procedure in Financial Matters in Chapter - 2 Parliament.
    2. Chapter - 5 Comptroller and Auditor General of India.
  - (b) PART VI of the Constitution of India – THE STATES
    1. Procedure in Financial Matters in Chapter – 3 The State Legislature.
  - (c) PART XII of the Constitution of India – FINANCE, PROPERTY, CONTRACTS & SUITS
    1. Chapter – 1 – Finance.
    2. Chapter – 2 – Borrowing.

As per Headquarters circular No. 10 of 1988 issued under letter No. 768-Exam/27-88 dated 09-08-1988, the office will not provide any training for the candidates appearing in the examination nor supply any books to the candidates. The books prescribed are priced

publications and the candidates should make their own arrangements to procure them. However, the candidates may make use of the copies of the prescribed books kept in the office library maintained by Record-I Section for reference.

The eligible candidates who intend to appear for the above-mentioned examination should submit their applications in the enclosed prescribed format to Admn-I Section on or before **11-04-2022**.
