Letter of Exam Wing (No.411/03-Exam/Exam-1/2021 dated 29/12/2021) on the examination schedule of 2022 refers. In view of the practical difficulties being faced by field offices due to the pandemic and changeover of the departmental examinations from conventional mode to MCQ, some offices have intimated that the SAS preliminary test and the required training is not on schedule. Therefore, it has been decided by the competent authority to postpone the SAS/RA/I/CPD-I, II & III Examination-1 of 2022 by one month. The Exam-1 of 2022 would now be conducted from 17th May to 23rd May 2022.
