Sub: Preliminary Examination for SAS-2 Exam of 2022.

The preliminary examination for SAS-2 Exam of 2022 for all the eligible officials, is to be conducted on 12-05-2022.

The preliminary examination and necessary training for all the **fresh** candidates be eligible for SAS examination would be conducted only **once** in a year.

The officials, who would be completing two years continuous service in one or more of the following capacities and successfully completing their probation period on or before 01-09-2022 would be allowed to appear in the preliminary examination.

- As a Clerk (Level 2 of Pay Matrix) or Accountant (Level 5 of Pay Matrix) or Senior Accountant (level 6 of Pay Matrix) or Assistant Supervisor (Level 7 of Pay Matrix) in an Account Office.
- 2. As a Data Entry Operator Grade 'A' (Level 4 of Pay Matrix) or Data Entry Operator Grade 'B' (Level 5 of Pay Matrix) in an Account Office.
- 3. As Stenographer Grade-I (Level 6 of Pay Matrix) or Private Secretary (PS) (Level 7 of Pay Matrix) in an Account Office.
- 4. As a Divisional Accountant (Level 6 of Pay Matrix) or Divisional Accounts Officer Grade II (Level 7 of Pay Matrix) under the administrative control of a Principal Accountant General (A&E).
- 5. As a Junior Translator (Level 6 of Pay Matrix) or Senior Translator (Level 7 of Pay Matrix) in an Account Office.
- 6. As a Supervisor (Level 8 of Pay Matrix).

Further, such officials, who are yet to complete their probation period, but are likely to complete the same on or before 01-09-2022 for SAS-2 Exam of 2022, would also be allowed to appear in the SAS (Preliminary) examination and in case of passing the SAS (Preliminary) examination, registered as a candidate for the ensuing SAS-2 Exam of 2022. In case of failure to complete the probation period successfully on 01-09-2022 the candidature of such officials would be cancelled. This would, however, not be counted as an attempt at the SAS Examination.

A candidate who had qualified in the preliminary examination scheduled in the past but absented or withdrawn his/her candidature from the immediately next SAS examination, and intend to appear for SAS exam again will be required to be re-screened in the forthcoming preliminary examination.

The Preliminary examination will include one paper of 100 marks (Paper-I) on General English/General Hindi and Constitution of India divided into two Sections of 50 marks each and another paper of 100 marks (Paper-II) on Service Regulations, Financial Rules and Principles of Government Accounts divided into two Sections of 50 marks each.

Keeping in view of the present change in pattern of examination from conventional mode to MCQ mode, the mode of answering will be descriptive mode for Part 'A' of Paper-I and MCQ mode for Part 'B'. As regards to Paper-II, the mode of answering both the Part 'A' & 'B' will be in MCQ mode. Use of Hindi medium of answering is permitted for Part 'A' of Paper I

The maximum number of chances to pass SAS exam is twelve (06 normal+06 additional). There are total 09 papers for SAS Exam. The eligible officials who could not pass 05 papers within the first (normal) 06 chances would be allowed to appear afresh for the preliminary examination without any carry forward of the exempted papers of SAS Exam.

The eligible officials who are willing to take preliminary examination may forward their applications in the proforma enclosed so as to reach Admn-I Section on or before 22-04-2022 positively.
