**CIRCULAR**

**Subject: Appointment to the post of Deputy General Manager in the  
Departmental Canteen of this office on deputation basis**

One post of Deputy General Manager in the Departmental Canteen in the Level-6 General Central Service (Group B), Non-Gazetted, non-Ministerial is to be filled in this office on deputation basis (Including Short Term Contract). The deputation will be governed on the usual terms and conditions issued from time to time by the Government of India, the period of deputation will be initially for a period of one year and period of deputation shall ordinarily not exceed three years subject to his/ her continued suitability.

**Eligibility Criteria for Deputation:**

Officials of the Central Government;

- A) (I) Holding analogous posts on regular basis in the parent cadre or department; or  
(II) With six (6) years in the grade rendered after appointment thereto on a regular basis in posts in Level-5 of Pay Matrix or equivalent in the parent cadre or Department; or  
(III) With ten (10) years service in the grade rendered after appointment thereto on a regular basis in posts in Level-4 of Pay Matrix or equivalent in the parent cadre or Department; and

B) Educational Qualification:

- (I) Bachelor's degree in Commerce or Business Studies or Economics or Public administration from a recognized University or Institute  
(II) Two years experience in Accounts work in any Government office or Public Sector Undertaking or Autonomous or Statutory Organization.

Qualification regarding education and experience is/ are relaxable at the discretion of the competent authority.

The period of deputation including period of deputation in any other ex-cadre post held immediately preceding this appointment in the same or some other organization or Department of Central Government shall ordinarily not exceed three year.

The maximum age limit for appointment by deputation shall not exceed 56 years as on the closing date of receipt of applications.

The willing officials may submit their application through proper channel.
