**CIRCULAR**

**Subject: Appointment to the post of Assistant Halwai-Cum-Cook in the  
Departmental Canteen of this office on deputation basis**

Two posts of Assistant Halwai-cum-Cook in the Departmental Canteen in the Level-2 General Central Service (Group C), Non-Gazetted, non-Ministerial is to be filled in this office on deputation basis. The deputation will be governed on the usual terms and conditions issued from time to time by the Government of India, the period of deputation will be initially for a period of one year and period of deputation shall ordinarily not exceed three years subject to his/ her continued suitability.

**Eligibility Criteria for Deputation:**

Officials of the Central Government -

- (i) holding analogous post on regular basis; or
- (ii) Canteen Attendant in Level I in the Pay Matrix with atleast three years' regular service in the grade having one year experience as helper to Halwai- cum-Cook; and
- (iii) possessing a certificate or diploma in catering from a recognized institute.

The period of deputation including period of deputation in any other ex-cadre post held immediately preceding this appointment in the same or some other organization or Department of Central Government shall ordinarily not exceed three year.

The maximum age limit for appointment by deputation shall not exceed 56 years as on the closing date of receipt of applications.
