Subject: - Appointment of Welfare Assistant on deputation basis.

Applications are invited from willing Asstt Supervisors/ Sr. Auditors/ Sr. Accountants having three years of regular service in the grade in IA&AD for filling up of ex-cadre post of 01 Welfare Assistant at each of the following Defence Audit wing offices:-
