

NOTIFICATION

Applications are invited from retired Senior Audit Officers/Assistant Audit Officers (Commercial) to work as consultant on short term contract basis in the Office of the Principal Director of Audit (Railway Commercial), New Delhi.

The following terms and conditions would be applicable to the contractual officers:

1. The term of engagement shall be on a short term contract basis initially up to a period of one year. The maximum number of terms shall be restricted to five.
2. The maximum age up to which an individual may be engaged on contract basis, is 65 years.
3. Remuneration and allowances payable will be governed by OM No. 3-25/2020-E.IIIA dated 09.12.2020, issued by the Department of Expenditure, Ministry of Finance, Government of India, New Delhi, which is as under:
 - a) The retired person engaged on short-term contract basis shall be paid a fixed monthly amount, arrived at by deducting the basic pension from the pay drawn at the time of retirement. The amount so fixed shall remain unchanged for the term of the contract.
 - b) The retired person will not be entitled for annual increment/percentage increase, house rent allowance, residential accommodation, dearness allowances during the contract.
 - c) An appropriate and fixed amount as transport allowance for the purpose of commuting between the residence and the place of work shall be allowed not exceeding the rate applicable to the appointee at the time of retirement.
4. Paid leave of absence will be allowed at the rate of 1.5 days for each completed month of service, to retired officials hired on short term contract basis. Accumulation of leave beyond a calendar year will not be allowed. However, absence during curfew, bandh, strike, lockdown etc. shall be dealt with in a similar way, as in the case of serving officers/officials. If retired officers hired on short term contract basis remain absent beyond paid leave in a month for reasons other than those indicated above, remuneration shall be deducted on pro-rata basis as under:

5. Statutory deductions to be levied as per rules.
6. Retired officers, shall, as far as possible not be deputed on field audit duties/inspection. In case of exigencies, if the situation demands, a consultant may be required to go on tour as part of duty. If the consultant is deputed on field duties, TA/DA shall be paid as per their entitlement at the time of retirement.
7. The appointment will be purely on temporary basis subject to termination at any time.


