If retired officers hired on short term contract basis remain absent beyond paid leave in a month for reasons other than those indicated above, remuneration shall be deducted on pro-rata basis as under:

Fixed Monthly remuneration * Number of days of absence on working days

Statutory deductions to be levied as per rules.
Retired officers, shall, as far as possible not be deputed on field audit duties/inspection. In case of exigencies, if the situation demands, a consultant may be required to go on as part of duty. If the consultant is deputed on field duties, TA/DA shall be paid as per entitlement at the time of retirement.
Appointment will be purely on temporary basis subject to termination at any time.


