3. Eligibility for participation

Students under the age of 25 years as on 15 August 2022, enrolled in a course of study at an institution recognised by any University in India shall be eligible for participating in the competition.

4. Awards:

There are attractive cash prizes for winners. The top three entries in each category (English and Hindi) will be awarded prizes as follows:

First prize: ₹30,000

Second prize: ₹20,000

Third prize: ₹15,000

5. The details of the scheme shall be uploaded on the CAG's website, as well as the Government of India's Citizen Engagement Platform- mygov.in latest by 15th August 2022. A copy of the scheme document is enclosed herewith for ready reference.

The CAG has directed that in order to give wide publicity to the event and elicit maximum participation from the students, State PASG/AsG and DsG/PDs Central in a State may personally interact with the Universities, State Education Departments, Colleges and institutions located in their State/audit jurisdiction, informing them about the scheme, requesting them to circulate it among their students and encouraging them to participate wholeheartedly in the competition.
