Subject: Payment of Travel Concession to the Punjab Government pensioners – clarification regarding.

In continuation to this office circular No. Pen. Co-ordn./Punjab/Vol.-VI/OAA-TC/274 dated 13-03-2013, this is to state that the Government of Punjab in their circular letter No. FD-FPPC0MISC/284/2021-3FPPC dated 30-05-2022 has reiterated that Travel Concession will be paid to only one pensioner in the case both husband and wife are the Punjab Government pensioners. It has been clarified that in the cases where one of the spouses is Punjab Government employee and the other is Punjab Government pensioner, LTC/TC can be extended to only one of them. Both the husband and wife cannot claim the LTC/TC separately.

- 2. Pension disbursing authorities shall obtain an undertaking from the pensioner, as per Annexure-A (copy enclosed) before disbursing Travel Concession.
- 3. Having been authorized by the Pr. Accountant General (A&E), Punjab in their letter No. PEN-12/Imp.Order/SSA.NO.17/22-23/34A-34AJ dated 05-07-2022, it is requested to keep in view the clarifications mentioned above for payment of Travel Concession to the Punjab Government pensioners.
