ELIGIBILITY CONDITIONS FOR EXAMINATIONS

A. For fresh candidates:-

1. SAS (Civil Accounts and Civil Audit):

All the Sr. Accit/Acctt/DEOs/Clerk/Steno/PA/Jr.Translator/Sr. Translator/Assistant Supervisor/Supervisor/Divisional Accountants/DAO-II with two years of continuous service in one or more capacity in this office (i.e. O/o AG (A&E) Punjab and UT Chandigarh) who have successfully completed their probation period on cut-off date (i.e. 01.09.2022 for Examination-II) and who have passed the SAS Preliminary Examination and have also undergone the mandatory training are eligible. The condition of passing the Preliminary Examination is exempted for Divisional Accountants and DAO-II who have passed the Divisional Accountants Grade Examination.

2. Incentive Examination:

(i) All the Sr. AOs and Sr. DAOs are eligible.

(ii) All AAOs and DAO Grade-I who have completed one year of continuous service in their grade on the cut-off date (i.e. 01.09.2022 for Examination-II)

3. CPD-I Examination:

(i) All the Sr. AOs and Sr. DAOs are eligible.

(ii) All AAOs and DAO Grade-I who have completed four year of continuous service in their grade on the cut-off date (i.e. 01.09.2022 for Examination-II)

4. CPD-II Examination:

The candidates who have completed 04 years after passing the CPD-I Examination are eligibile for appearing in CPD-II Examination

B. For old candidates:

All the existing candidates of SAS/IE/CPD-I&II Examinations who have not exhausted their permissible chances are eligible.

Note:- 1. The SAS candidates who have exhausted ten chances and Incentive and CPD-I&II candidates who have exhausted their six chances can also apply for appearing in the Examination-I of 2021 as they have been granted two more chances as per HQrs Circular No. 11 of 2020 (for SAS Candidates) and Circular No. 03 of 2021 (for Incentive and CPD-I&II Candidates) which they have to avail within two years i.e. four examinations counting from Examinaiton-I of 2021.

2. The SAS (Civil Accounts) passed candidates who have not been appointed as Regular Assistant Accounts Officer are eligible for appearing in SAS (Civil Audit) Examination.

3. The SAS (Civil Audit) passed candidates who could not be absorbed in Audit Stream are eligible for appearing in SAS (Civil Accounts) Examination only after furnishing a written undertaking that they agree to forfeit their claim for deputation-cum- eventual absorption in any Civil Audit office.

4. Permission for switch over of SAS Examination branch, once granted shall be final, except switch back to "appropriate branch" in terms of Para 9.2.14 of CAG's MSO (Admn) Vol.I. SAS passed officials, who are still on deputation and not absorbed in other Cadre Controlling Offices, can switch back to "appropriate brach", only after joining in their parent office.
