
*Subject : Grant of Dearness Relief to the Tripura Government pensioners/
family pensioners with effect from 01-07-2022.*

In continuation to this office circular No. Pen. Co-ordn./Tripura/Vol.- VI/DR/38 dated 08-07-2021, this is to state that the Government of Tripura in their Memo No. F.5(1)-FIN(PC)/2021/299-372 dated 04-08-2022 has sanctioned dearness relief on the revised pension/family pension of their pensioners/family pensioners, as under :

Date of effect	Rate of dearness relief per month
01-07-2022	8% of revised basic pension/family pension

2. Payment of dearness relief involving fraction of 50 paise and above may be rounded to the next higher rupee and the fractions of less than 50 paise may be ignored.
3. Having been authorized by the Accountant General (A&E), Tripura in their letter No. Pen-1/Tripura Relief/2022-23/13721-13766 dated 11-08-2022, it is requested to make necessary arrangement for payment of dearness relief to all eligible Tripura Government pensioners/family pensioners @ 8% on their revised basic pension/family pension with effect from 01-07-2022 after proper adjustment.
4. The charges on this account are debitable to the head "8793-I.S.S.A/cs.; Government of Tripura etc."
