Date of effect	Rate of dearness relief per month
01-07-2022	8% of revised basic pension/family pension

2. Payment of dearness relief involving fraction of 50 paisa and above may be rounded to the next higher rupee and the fractions of less than 50 paisa may be ignored.

Having been authorized by the Accountant General (A&E), Tripura in their letter No. Pen-1/Tripura Relief/2022-23/13721-13766 dated 11-08-2022, it is requested to make necessary arrangement for payment of dearness relief to all eligible Tripura Government pensioners/family pensioners @ 8% on their revised basic pension/family pension with effect from 01-07-2022 after proper adjustment.
