#### **CIRCULAR**

The Divisional Accountant Grade Examination will be held in the month of September, 2022 as per the programme appended hereto in the office of the Accountant General (A&E), Odisha, Puri.

All Divisional Accountants (Probationer) who are completing one year of training as on 25.09.2022 are directed to send their application in the enclosed proforma to WM Section by **16.09.2022** positively. Divisional Accountants (Probationer) who will be completing **at least 10 months of service as on 25.09.2022** and willing to appear in the September 2022 Examination may also apply along with a separate application for condonation. They will be permitted to appear for the examination subject to condonation of the deficiency in services by the Competent Authority.

The syllabus of the examination is given in Annexure-II to the Chapter-VII of the C.A.G.'s Manual of standing Orders (Admn.)-Vol-I.

Candidates are allowed to use their own simple calculators for performing basic arithmetical functions like addition, subtraction, multiplication and division as well as calculation of percentage while appearing in the examination.

Besides, candidates will be required to pass language test in Odiya as prescribed. Candidates who have passed H.S.C. examination or equivalent/Higher examination with Odiya as one of the subjects are exempted from appearing for the language test in Odiya provided they furnish documentary evidence to that effect.
