In continuation to this office circular No. Pen.Co-ordn./Gujarat/Vol.-VI/DR-unrev/116 dated 20-01-2021, this is to state that the Government of Gujarat in their FD Resolution No. HGV 2008-500-P dated 29-07-2022 has sanctioned Temporary Increase (dearness relief) to their pensioners/family pensioners whose pension/family pension has not been revised as per Government of Gujarat FD Resolution No. PGR-1009-4-Pay Cell (M) dated 13-04-2009 (communicated vide circular No. Pen.Co-ordn./Gujarat/Vol.-V/Revision/72 dated 25-08-2009), as under:

Date of effect	Rate of Temporary Increase per month
01-07-2019	312% of basic pension/family pension
	(Including Dearness Pension/Dearness Family Pension)

Payment of Temporary Increase involving a fraction of a rupee shall be rounded off to the next higher rupee.

- Other provisions governing grant of Temporary Increase to pensioners such as regulations of dearness relief during employment/re-employment, regulation of Temporary Increase, where more than one pension is drawn etc. will remain unchanged.
- Having been authorised by the Principal Accountant General (A&E), Gujarat in their letter No. Pension/G.R/Special Seal/02,03,04,05/2022-23/OW No. 568 dated 25-08-2022, it is requested to make necessary arrangement for payment of Temporary Increase to all eligible Gujarat Government pensioners/family pensioners on their revised basic pension/family pension @ 312% on the total of their basic pension/family pension and Dearness Pension/Dearness Family Pension with effect from 01-07-2019 after proper adjustment.
