**Subject : Grant of dearness relief @ 196% to the Goa Government
Freedom Fighter pensioners/family pensioners
with effect from 01-07-2021.**

In continuation to this office circular No. Pen. Co-ordn./Goa/Vol.-V/DR-FF/166 dated 15-02-2022, this is to state that the Government of Goa in their FD Order No. 11/4/2012-HD(G)/6695 dated 25-05-2022 has adopted the rate of dearness relief announced by the Central Government in respect of their Freedom Fighter pensioners/family pensioners, as under :

Date of effect	Rate of dearness relief per month
01-07-2021	196% of basic pension/family pension

2. Payment of dearness involving a fraction of a rupee shall be rounded off to the next higher rupee.

3. Having been authorised by the Director of Accounts, Government of Goa in their letter No. DA/PA-I/Pens/22-23/DR-748/TR-249 dated 15-06-2022, forwarded with letter No. DA/PA-I/Pens (5)/A.G. West Bengal/22-23/1260 dated 12-08-2022, it is requested to make necessary arrangement for payment of dearness relief on pension/family pension to the Goa Government Freedom Fighter pensioners/family pensioners @ 196% with effect from 01-07-2021 after proper adjustment.
