In continuation to this office circular No. Pen.Co-ordn./Gujarat/Vol.-VI/DR/58 dated 16-06-2022, this is to state that the Government of Gujarat in their FD Resolution No. HGV-102017-O-450-P dated 20-08-2022 has sanctioned Temporary Increase (dearness relief) on revised pension/family pension of their pensioners/family pensioners as under:

Date of effect Rate of Temporary Increase per month
01-01-2022 34% of basic pension/family pension

2. Temporary Increase at the rates indicated in above table will also be admissible on the additional basic pension/family pension available to older pensioners/family pensioners based on their age.

Payment of Temporary Increase involving a fraction of a rupee shall be rounded off

to the nearest lower or higher rupec.

- 4. The said Temporary Increase will be paid regularly along with monthly pension from August, 2022, the difference of 7 (seven) months from January 2022 to July 2022 of the proposed Temporary Increase will be paid in three installments: first installment (January 2022 to March 2022) and second installment (April 2022 to June 2022) along with the pension of September 2022 and third installments (July 2022) along with the pension of October 2022.
- 5. Other provisions governing grant of Temporary Increase to pensioners such as regulations of dearness relief during employment/re-employment, regulation of Temporary Increase, where more than one pension is drawn etc. will remain unchanged.
- 6. Having been authorised by the Principal Accountant General (A&E), Gujarat in their letter No. Pension/G.R/Special Scal/02,03,04,05/2022-23/OW No. 568 dated 25-08-2022, it is requested to make necessary arrangement for payment of Temporary Increase to all eligible Gujarat Government pensioners/family pensioners on their revised basic pension/family pension @ 34% with effect from 01-01-2022 after proper adjustment.
