The Candidates as per Annexure-A are allowed to appear at the Divisional Accountant Grade Examination, September, 2022 to be held in the Examination & Training Centre of Pr. Accountant General (A&E) Odisha, Bhubaneswar as per the programme given below.

The candidates are required to provide this intimation to the Superintendent of the examination, failing which they will not be allowed to enter into the examination Hall. They should bring their specimen signature duly attested by one Gazetted officer to establish their identity.

The candidates should present at least 30 minutes before commencement of the examination. No candidate will be permitted to enter into the examination Hall after 30 minutes of the commencement of the examination or leave the hall earlier than 15 minutes before the end of the examination.

Candidates are allowed to use their own simple calculators for performing basic arithmetical functions like addition, subtraction, multiplication and division as well as calculation of percentage while appearing in the examination. **However, no other electronic instruments including Mobile Phones are allowed into the examination Hall.**

Candidates resorting to unfair means/malpractice/copying will be debarred from the examination and liable for disciplinary action.

**The candidates should maintain Covid-19 propriety behavior during the examination.**

The candidates are allowed to write all the papers either in English/Hindi as per the options given by them.


