Further, the Committee shall be required to meet once a quarter, even if there is no live case. In terms of Headquarters letter No. 101-Staff (Disc.)-17-2018 dated 31.03.2015, the Committee shall submit an annual return to Headquarters Office on cases of sexual harassment against working women pertaining to the period from 1<sup>st</sup> April to 31<sup>st</sup> March each year, in the proforma enclosed therewith. Besides, the Committee may furnish details of number of complaints received, disposed of and action taken in the case, to the Administration Section to enable this Office to sent monthly report to
