The Presiding Officer/ members of the Committee shall hold the position for such period not exceeding three years. Further, the Committee is required to meet once in each quarter, even if there is no live case. In terms of Headquarters letter No. 101-Staff (Disc.)-17-2018 dated 31.03.2015, an annual return on cases of sexual harassment against working women pertaining to the period from 1st April to 31st March each year, is to be sent to Headquarters Office in the prescribed proforma. Further, the Committee may furnish details of number of complaints received, disposed of and action taken in each case to Headquarters; as required under Office Memorandum dated 22.12.2016 of Department of Personnel & Training, Government of India, communicated by the Headquarters vide letter No. 03-Staff Entt. (R)/A.R/04-2015 dated 13.01.2017.

While discharging its functions, the Committee may follow applicable Act/Rules and instructions/guidelines issued by the Headquarters Office and Department of Personnel & Training, Government of India, from time to time.
